

TERMS AND CONDITIONS OF USE

Introduction

These terms and conditions apply between you, the User of this Transper Platform (including any sub-domains, unless expressly excluded by their own terms and conditions), and Sabstone Ltd, the owner and operator of this Transper Platform. Please read these terms and conditions carefully, as they affect your legal rights.
